clonidine**	generic 0.025 mg tabs	0.05 mg bid	Some women may require higher doses (ie 0.05 mg tid), but side effects may limit use. Taper slowly to discontinue. Not recommend by the NAMS non-hormonal position statement 2023.

gabapentin*	Neurontin®, generics 100, 300, 400 mg caps 600, 800 mg tabs	Start 300 mg daily, then increase to 300 mg tid at 3 – 4 day intervals***	May take $1-2$ weeks to see effective dose for VMS.
pregabalin*,**	Lyrica®, generics 25, 50, 75, 100, 150, 200, 225, 300 mg caps	150 – 300 mg daily	Less well studied in menopause, not recommend by the NAMS non-hormonal position statement 2023.

^{**}clonidine and pregabalin are not recommended by The Menopause Society (previously NAMS) Non-hormonal Position Statement 2023 as there are more effective agents with fewer side effects. Menopause 2023;30(6):573-590

^{***}gabapentin can also be used as a nightly dose to help with sleep. It is recommended to start with 300 mg nightly and increase in increments of 100 mg to doses of 600 – 900 mg nightly.
